- All fish caught must be measured using the DAA Founder's Cup measuring stick with a picture.
- Pictures must be clear and include the entire fish on a flat surface with the stick visible on top of fish from the tip of the snout to the tip of the tail. Email to tammyakirk@yahoo.com.
- Indicate category on the submission of the photo: fly or lure/bait.
- The camera should have a time stamped with correct time and date.

Fishing Rules

- Boundaries - Green Harbor to Mahomet
- Entrants may fish from private boats, as clients on charter boats, or with guides.
- All boats must meet U.S. Coast Guard Requirements and are the sole responsibility of the boat owner.
